8. The bid will be opened in the presence of Bidders' representatives who choose to attend at **14:00, on June -11, 2020** at the Gadhwara Rural Municipality, Dang. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security amounting to a minimum of following amount, which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
