1. The Gadhwara Rural Municipality has allocated funds towards the cost of **Koilabash Park Construction Work** under the below mentioned Contracts. Bidding is open to all eligible Nepalese Bidders.
2. Bidders may bid for one or several contracts, as further defined in the Bidding Document. Bidders wishing to offer discounts/cross discounts in case they are awarded more than one contract will be allowed to do so provided those discounts are included in the Letter of Bid.
3. **Gadhawa Rural Municipality, Dang** invites sealed bids from eligible bidders for the Construction of **Koilabash Park Construction Work at Ward-8** (10/GRM/NCB/075/076 under National Competitive Bidding procedures.
4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the **Gadhawa Rural Municipality, Dang (082-410004)** or may visit PPMO website www.bolpatra.gov.np/egp.
5. A complete set of Bidding Documents may be purchased from the **Gadhawa Rural Municipality, Dang** by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee till 5:00 PM, July-02, 2019.

Bidders, submitting their bid electronically, should deposit the cost (as specified above) of bidding document in the Dharuti Khatana as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 8. No Pre-bid meeting shall be held.
9. Sealed bids must be submitted to the Gadhwara Rural Municipality, Dang on or before **12:00** on July-3, 2019. Bids received after this deadline will be rejected.
10. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00, on July-3, 2019** at the Gadhwara Rural Municipality, Dang. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security amounting to a minimum of following amount, which shall be valid for 30 days beyond the validity period of the bid.
11. If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
